

## **PERSONAL DATA PROTECTION.**

1. **LEDESMA S.A.A.I.** respects the privacy and personal data of all users who visit Ledesma S.A.A.I.'s WebSite (hereinafter, the "WebSite"). We inform you that users can access the WebSite without providing personal data. If users provide personal information, they authorize **LEDESMA S.A.A.I.** to its access in accordance with the terms set forth herein. Personal data will be collected through the WebSite, when users enter information in any of the fields intended for this purpose on the Website. These fields are properly marked;

2. In compliance with clause 6 - Law 25.326 (*Protection of Personal Data*), users are aware that, the data provided to **LEDESMA S.A.A.I.** for the use of the Website are used - exclusively - to respond to users queries, in a framework of full compliance with applicable regulations;

3. Users, that provide personal data, become aware of the right to access to their personal data free of charge and also that they have the right, if appropriate, to rectify, delete, withdraw or block data, as well as to limit their treatment, or to oppose to its treatment, entirely or in part, by sending an email to [LEDESMADIALOGA@LEDESMA.COM.AR](mailto:LEDESMADIALOGA@LEDESMA.COM.AR) with the subject: "PERSONAL DATA". In no case **LEDESMA S.A.A.I.** will retain personal data for more time of the essential;

4. Users become aware of the existence of a Data Bank where their personal information is stored, located at Av. Corrientes No. 415, 8th Floor, Autonomous City of Buenos Aires (C1043AAE), Argentina, belonging to **LEDESMA S.A.A.I.**, who is the only responsible for it, and that in no case the data provided will be delivered to third parties. Such information is completely confidential, between the user and **LEDESMA S.A.A.I.**, unless the information is required to **LEDESMA S.A.A.I.** by a Court resolution or by Competent Government Authority. All the information provided by the users, must be true, accurate and complete;

7. The personal data, requested from the WebSite - for those users interested in making queries - are the following: (i) First and Last Name and (ii) Email Address. Our goal is that personal data requested is accurate, relevant and not excessive;

The personal data and other personal information regarding labor, educational and academic nature, among others, contained in the curriculum vitae of those users who had sent them to **LEDESMA S.A.A.I.** through the WebSite, will be treated in accordance with this terms, in a framework of full compliance with the applicable regulations, and for the purpose indicated in the respective section of the WebSite;

The National Data Protection Agency is the enforcing authority (Law 25.326) in the Argentine Republic and has the power to respond to complaints and claims that are filed in relation to protection of personal data and to attend to reports and claims regarding non-fulfillment of data protection provisions (Sections 14, 15 and 16 - Law 25.326 and Provision No. 10/08 of the "DNPDP" Section 27- subsection 3. - Files, records or databases for advertising purposes). "The holder may, at any time, request the withdrawal or blocking of his name from the data banks referred to in this section." Decree 1558/01 – Annex I-Section.- 3rd paragraph. *"In all communication for advertising purposes that are carried out by mail, telephone, email, Internet or other remote means to be known, the possibility of the holder of the data requesting the withdrawal or blocking should be indicated expressly and prominently , total or partial, in your database name. At the request of the interested party, the name of the person in charge or user of the data bank that provided the information must be informed"*. If the user is a resident of a country outside the Argentine Republic, he may exercise his rights - regarding data protection - by contacting the responsible authority of his respective country.
